

## 2019 APPLICATION PROCEDURE FOR A UIM AQUABIKE SUPERLICENCE

### 203.02 - ENTRIES - UIM SUPERLICENCE

#### 203.02.01 - SUPERLICENCE CONDITIONS

The World Superlicence or the Continental Superlicence is to be requested 4 weeks before the first event with a photograph.

Superlicence will be issued through the UIM Secretariat only. The pilot must have a valid licence delivered by a National Authority recognized by the UIM and following the UIM activities in Aquabike racing.

The holder of a World or Continental Superlicence cannot be refused by the organizing National Authority except in case of serious fault during the season.

#### 203.02.02 - SUPERLICENCE CRITERIA

- **Four national races or international ordinary races.**
- **Sports CV with official results.**
- **To provide a valid attestation of Civil Responsibility insurance in and out race for a minimum amount of 1.000.000 Euro and with the exception of coverage of the pilots and their Aquabike amongst drivers.**
  1. The attestation of Civil Responsibility insurance will have to be provided written in English or French with the amount of coverage in Euro, no attestation written in another language and/or other currency will be taken into account.
  2. In the event you cannot obtain a Civil Responsibility insurance as per the above rule, please refer to page 4 and 5 of the 2019 UIM Aquabike Superlicence procedure.

## **SUPERLICENCE FEE**

### **203.02.03 - YEARLY SUPERLICENCE FEE**

- World Superlicence 150 Euro
- Continental Superlicence 75 Euro

### **203.02.04 - DAILY LICENCE FEE**

- World Championship 50 Euro
- Continental Championship 25 Euro

The daily Licence is valid for one race only and cannot be deducted when a World or Continental Superlicence is taken.

## **SUPERLICENCE RIGHTS**

*The UIM Superlicence gives to the drivers the following rights:*

- *To cash the travel proportional money as follows for World Championship events, according to Event Advance Notice:*

*The first 10 drivers for RUNABOUT GP1*

*The first 10 drivers for SKI DIVISION GP1*

*The first 10 drivers for SKI DIVISION WOMEN GP1*

*The first 4 drivers for FREESTYLE*

- *To cash the proportional travel money for the 3 drivers at Continental Championship (according to Event Advance Notice)*
- *To get a trophy for the first 3 drivers for World and Continental Championships*
- *To get the UIM points if rider is among the 15 first drivers for World and Continental Championships*
- *To get points for the UIM Aquabike World Ranking (for more information please go to <http://www.aquabike.net/standings.php>)*

**APPENDIX 3 – Consent form

1. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the UIM Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the “Code”) and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA’s website.
2. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House (“ADAMS”), as requested under the Code to which UIM is a Signatory, and/or any other authorized National Anti-Doping Organization’s similar system for the sharing of information, and to the entry on my Doping Control, Whereabouts and Therapeutic Use Exemptions related data in such systems.
3. I acknowledge the authority of UIM [and its member National Federations and/or National Anti-Doping Organizations] under the UIM Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the UIM Anti-Doping Rules.
4. I acknowledge and agree that any dispute arising out of a decision made pursuant to the UIM Anti-Doping Rules, after exhaustion of the process expressly provided for in the UIM Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the UIM Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
5. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.

## UIM - H2O Racing / Civil Responsibility Insurance

### 2019 AQUABIKE WORLD CHAMPIONSHIP

For the 2019 racing season, H2O racing will again offer to the Aquabike drivers the possibility to take out a **GLOBAL CIVIL RESPONSIBILITY INSURANCE POLICY** which will cover the Aquabike drivers for the **2019 Aquabike Circuit World Championship events only**.

The amount of this insurance cover is **350€ for the 2019 season or 75€ per event, both offers are VALID FOR THE 2019 CIRCUIT WORLD CHAMPIONSHIP ONLY**, to cover the Aquabike drivers holding a **2019 World Aquabike Superlicence** who have not been able to provide a valid proof of insurance cover as requested by the UIM Rulebook, when they applied for the 2019 Aquabike Superlicence.

#### I. THE 2019 WORLD AQUABIKE SUPERLICENCE (yearly Superlicence)

The UIM will therefore issue two versions of the annual 2019 World Aquabike Superlicence:

- **The 2019 World Aquabike Superlicence:** for the Aquabike driver who is able to provide a valid attestation of Civil Responsibility insurance in and out of race for a minimum amount of 1.000.000 euro and with the exception of coverage of the pilots and their Aquabike amongst drivers (as per rule 203.02.02 of the 2019 Aquabike rulebook).

*(The attestation of Civil Responsibility insurance will have to be provided written in English or French with the amount of coverage in Euro, no attestation written in another language and/or other currency will be taken into account)*

- **The 2019 World Aquabike Superlicence with insurance:** for the Aquabike driver who cannot provide a valid proof of such insurance cover and who will have to obtain the required insurance cover through UIM/H2O racing. The corresponding amount of **350 €** is payable at the same time as drivers apply for the Superlicence. *(ie. 150€ for the Aquabike Superlicence + 350€ for the insurance = 500€).*

#### II. THE 2019 WORLD DAILY AQUABIKE SUPERLICENCE (Single event Superlicence)

As per the Aquabike rule 203.02.04, any Aquabike drivers can also apply for an **Aquabike World Daily Superlicence** (50€) to the UIM office until 3 days prior to the event or on-site upon registration.

- Every drivers will also have to provide a valid attestation of Civil Responsibility insurance in and out of race for a minimum amount of 1.000.000,00 euro and with the exception of coverage of the pilots and their Aquabike amongst drivers (as per rule 203.02.02 of the 2019 Aquabike rulebook).

*(The attestation of Civil Responsibility insurance will have to be presented to the UIM office or the UIM Commissioner written in English or French with the amount of coverage 1.000.000€ in Euro, no attestation written in other language and/or other currency will be taken into account)*

Any driver who cannot provide such insurance cover document upon SL application will be able to take a single event insurance. The amount of **75€ per event/per driver** will have to be paid to the UIM when applying 3 days prior to the event or to the race secretariat when applying for the SL on-site.

## UIM NATIONAL AUTHORITY / Civil Responsibility Insurance

### 2019 AQUABIKE CONTINENTAL CHAMPIONSHIP

For the 2019 Aquabike Continental Championship, the insurance cover **will be provided by the National Authorities hosting the 2019 Aquabike Continental Championship.**

The amount of this insurance cover cannot exceed **90€ per driver/per event.** However, the exact amount will be confirmed in the event's advance notice.

#### **I. THE 2019 CONTINENTAL AQUABIKE SUPERLICENCE**

- **The 2019 Continental Aquabike Superlicence:** for the Aquabike driver who is able to provide a valid attestation of Civil Responsibility insurance in and out of race for a minimum amount of 1.000.000 euro and with the exception of coverage of the pilots and their Aquabike amongst drivers (as per rule 203.02.02 of the 2019 Aquabike rulebook).

*(The attestation of Civil Responsibility insurance will have to be provided written in English or French with the amount of coverage in Euro, no attestation written in another language and/or other currency will be taken into account)*

- **The 2019 Continental Aquabike Superlicence without insurance:** for the Aquabike driver who cannot provide a valid proof of such insurance cover and who will have to take the insurance cover provided by the hosting National Authority on-site when registering to the race Secretariat.

#### **II. THE 2019 WORLD DAILY AQUABIKE SUPERLICENCE** (Single event Superlicence)

As per the Aquabike rule 203.02.04, any Aquabike drivers can also apply for an **Aquabike European Daily Superlicence** (25€) to the UIM office until 3 days prior to the event or on-site upon registration.

- Every drivers will also have to provide a valid attestation of Civil Responsibility insurance in and out of race for a minimum amount of 1.000.000,00 euro and with the exception of coverage of the pilots and their Aquabike amongst drivers (as per rule 203.02.02 of the 2019 Aquabike rulebook).

*(The attestation of Civil Responsibility insurance will have to be presented to the UIM office or the UIM Commissioner written in English or French with the amount of coverage 1.000.000€ in Euro, no attestation written in other language and/or other currency will be taken into account)*

Any driver who cannot provide such insurance cover document upon SL application will be able to take a single event insurance. This specific TBC amount will have to be paid to the race secretariat when applying for the SL on-site.
